Dear Parent/Guardian:

Eighth grade students of the Joseph L. McCourt Middle School will have their eighth grade outing on Thursday, June 10, 2010 at the High Meadow Recreational Facility in Granby, CT. This is a well supervised facility that comes highly recommended and is well trained in dealing with school groups. Only middle/junior high schools will be utilizing the facility on that day. Our sister school, North Cumberland Middle, will also be at High Meadow that day.

Cost for the entire day will be \$50.00 this includes transportation, all activities, breakfast, lunch, snack food throughout the entire day, unlimited soda and ice cream, etc. There are no additional costs except for students who wish to go horseback riding. The cost for horseback riding is \$20. While the cost might seem high, it is all inclusive and we are ensuring that all eligible children are given an opportunity to attend. If cost is a problem, please feel free to contact me to discuss the issue.

Please remember, students who have not met their academic or behavioral expectations, will not be able to attend. Supervision will be provided by McCourt Middle School faculty, as well as the well trained staff of the High Meadow Facility. All school rules and regulations will be enforced.

Students will travel by bus from McCourt Middle to Granby, CT. Departure time will be 6:45 A.M. from the McCourt Middle School parking lot with a return to Cumberland at approximately 6:15 P.M. Please make arrangements for someone to pick up your son/daughter at that time.

An initial deposit of \$25.00 or full payment should be sent to school along with the signed permission form no later than Friday, May 28, 2010. If a deposit is made, a balance of \$25.00 must be received by Friday, June 4, 2010. Students who intended on attending but become ineligible due to academic or behavioral reasons will have their money refunded.
